### **Grant Description**

This enhancement grant will enable the YMCA program at the Gardner to recruit, enroll and sustain 9 more students with IEPs to bring their total to 26 students with IEPs during the school year and summer. Funding will be used to augment the existing programming to ensure full inclusion through: staff training and planning time about supporting students with disabilities, differentiated instruction, curriculum modifications; family support.

### **Expense Categories this Grant Pays For**

- ~80% instructional direct staffing
- ~10% SPED consultant: Learning Specialist
- ~10% program supplies

### Specific, Measurable, Attainable, Realistic, and Time-bound (SMART) Goals

**Goal #1:** 85% of students on IEPs participating in programs at the Gardner will improve ELA performance by at least 10% from the pre-test to the post-test.

**Indicator:** Rate of growth will be measured by the Survey of Academic Youth Outcomes Pre- and Post-Assessments for Teachers (SAYO-T), a reliable and valid measure developed by the National Institute for Out-of-School Time for this use by MADESE.

**Goal #2**: The number of students served in the 21<sup>st</sup> CCLC afterschool program on IEPs will increase by at least 9 as compared to last year's enrollment and these additional students will attend at least 100 hours of programming (the minimum number of hours found by research to be necessary for significant positive gains).

Indicator: Enrollment/attendance review.
